



## **Specification & Contract No. 1429**

### **33KV INDOOR SWITCHGEAR AT TRANSGRID'S TAREE SUBSTATION**

#### **Summary of Specification**

---

The following summary indicates the general nature of the work for which TransGrid desires tenders to be submitted. It is issued to enable an assessment to be made whether the Specification documents should be obtained from TransGrid for tendering purposes. It does not form part of the Specification and must not be included as part of your offer.

The Specification documents are available for a non-refundable fee of \$220. They may be downloaded from TransGrid's e-tendering web-site.

#### **Extent of Work**

TransGrid requires new 33kV indoor switchgear with a combined control/protection system to be installed in a switchgear building at TransGrid's Taree substation.

The Work under the Contract as detailed in this Specification covers all works necessary for the design, provision of interfacing information, manufacture, test at Works, provision of "As Manufactured" drawings for the switchgear and switchgear accessories, transport and delivery to the nominated Site and subsequent erection for the 50Hz, 33kV indoor switchgear. The Concept Drawings provide additional information in relation to the intention of the Work.

The Work also includes the provision of all design, services, labour, materials, consumables, equipment and supervision necessary for the completion of Works.

#### **Mandatory Criteria**

Tenders submitted by organisations that do not comply with all the following mandatory criteria will not be considered:

- Tenders must be for the whole of the works specified. Tenders for only part of the work will not be considered.
- The Contractor shall have an accredited Health and Safety Management System. The system must be accredited to the requirements of the following:

AS4801:2001 – Occupational Health and Safety Management System

As well as either:

NSW Government Occupational Health & Safety Management Systems Guidelines 4th Edition and be accredited by Department of Financial Services or 5th Edition and be accredited by JAZ-ANZ prior to the Contractor being awarded a Contract to deliver works and commencing work on Site.

Or

Accreditation to the Australian Government Building and Construction Occupational Health & Safety scheme administered by the Office of the Federal Safety Commissioner

#### **Contract Period**

Practical Completion of all Works within this Specification is required within 66 weeks from the date of Acceptance of Tender.

#### **Contract Closure**
