# PART 1 – REQUEST FOR TENDER

#### **A** Introduction

#### A.1 Preface

- A.1.1.1 The Western Sydney Regional Organisation of Councils Ltd (WSROC) Supply Management Group (SMG) is seeking Tenders from suppliers with the proven ability to provide timely and cost effective delivery of a wide range of asphalt associated services for an initial period of 3 years with an option to extend for a further 2x1 year periods.
- **A.1.1.2** WSROC comprises eleven (11) Western Sydney Area Councils. The following Councils have confirmed their intention to participate in this RFT (Request for Tender).

- **A.1.1.3** The support from external providers for cost effective supply solutions is critical to the ongoing support of each Council's operations.
- A.1.1.4 The WSROC SMG has been actively establishing Supply Arrangements for various products and services that meet the needs of member Council's & its Customers. These collective supply arrangements allow the market place to take advantage of a higher volume of supply providing a range of benefits and offsets that we anticipate will in turn provide us with cost effective supply solutions whilst maintaining a high degree of quality and satisfaction.
- **A.1.1.5** WSROC SMG anticipates that suppliers, by assisting in the process improvement and total quality management processes, will ensure that WSROC achieves the "best value" for the acquisition of goods and/or services.
- **A.1.1.6** The purpose of this Request for Tender (RFT) is to establish a Contract agreement with a number of Contractors who can demonstrate their ability in meeting the requirements detailed in this document for services that have been tendered.

#### A.1.2 Tender Scope

- A.1.2.1 The WSROC Councils intend to upgrade their infrastructure to various levels over the forthcoming tender period. This Tender document calls for the provision of the following goods and services as separate contracts:
- A.1.2.1.1 Sprayed Bituminous Surfacing
- A.1.2.1.2 Stabilisation (Cementitious)
- A.1.2.1.3 Stabilisation (Bituminous)
- A.1.2.1.4 Ex-bin / Supply and Deliver Asphalt
- A.1.2.1.5 Asphalt Works
- A.1.2.1.6 Road Restoration
- A.1.2.1.7 Profiling
- A.1.2.2 The goods and services listed in A.1.2.1 are to be procured for use where the Council does not undertake the activity, or the activity is not part of a larger scope of works that is separately outsourced and procured.
- A.1.2.3 Individual WSROC Member Councils do not bind themselves to accept any or all offers submitted. Some other WSROC Member Councils may elect to do so. Contract rates are structured on a volume based arrangement, and therefore the rates tendered are applicable to the collective quantity of works for Councils who do accept the offer from a particular Contractor.
